Officer Payne continued to give Lowery commands, "get down." Lowery turned, took a step to the gate and climbed over. Officer Payne approached the gate with his firearm in his left hand and his Taser in his right hand. Lowery was on the opposite side of the gate as Officer Payne. Evidence supports that Officer Payne simultaneously pulls the trigger of his Taser and his firearm. Officer Payne fired a single gunshot striking Lowery in the back of his head and killing him. There were no weapons found on Lowery or in his vicinity. Brevard County Medical Examiner's autopsy report. Medical Examiner Sajid Qaiser, MD, reported that the cause of death for James Lowery was due to gunshot wound of head. The manner of death was listed as a homicide.
