On page 2 of 2, you write in the fourth full paragraph on the page, "After explaining the new transition committee, Chairman Sanchez stated that he and Hunt had conversations about selecting the members for the transition team "

When I re-watched the September 18, 2019, GOAA Board Meeting, at around the 12 40 mark, Phil Brown is presenting the revised plan for the transition team and he explains that there are new people on the transition team. Brown explains that pursuant to the GOAA bylaws, Chairman Sanchez is allowed to make changes to the people making up the transition team. Chairman Sanchez then interjects and confirms what Phil Brown had just said, which is that he and Phil Brown had talked about who should be on the transition team.

So, I suspect that what you meant to write in IR Number 1 is actually, "After explaining the new transition committee, Chairman Sanchez stated that he and Hunt Brown had conversations about selecting the members for the transition team"

Can you take a look at this for me, please? Although this is a minor scrivener's error in your report, it is impactful on our case because as currently written, the sentence tends to indicates that Sanchez and Hunt (two members of the GOAA Board) had conversations about who should be on the transition team, which could be a violation of Sunshine Law But, if what I am hearing from the September 18, 2019, GOAA Board Meeting recording at 12 40 or so is correct, Sanchez says that he and Brown discuss the matter, and that is NOT a violation of Sunshine Law

In October of 2019, FDLE Inspector Charles Dickson received documentation related to the complaint from Chief Assistant State Attorney Stacey Salmons of the Eighteenth Judicial Circuit The documentation included a letter from the Executive Office of the Governor which stated that due to a potential conflict of interest the complaint and investigation were transferred from the Ninth Judicial Circuit to the Eighteenth Circuit The documentation provided by Salmons included board minutes and agendas from GOAA board meetings that were held on August 28, 2019 and September 18, 2019 respectively Inspector Dickson reviewed the board minutes and also watched the meetings in question online via the GOAA website

In essence, the nature of the allegations was that GOAA board members may have violated Florida Sunshine Laws (Florida State Statutes Chapter 286) by conducting official GOAA business outside of board meetings as it related to the potential hiring of James Perry and Tara Tedrow Both Perry and Tedrow were being considered for the position of interim general counsel for GOAA due to the vacancy left by outgoing General Counsel Marcos Marchena After reviewing the allegations and board meetings in question, Inspector Dickson and Chief Assistant Salmons conducted eleven investigative interviews in total for the purpose of obtaining sworn statements Voluntary, sworn statements were taken from Perry, Tedrow, members of Tedrow's law firm of Lowndes, Drosdick, Kantor, and Reed, GOAA board members, GOAA Chief Executive Officer (CEO) Phil Brown and Orlando lobbyist Christopher Dorworth GOAA Board Members Randall Hunt and Domingo Sanchez were contacted and provided with an opportunity to speak about the allegations but neither wished to provide a statement to Inspector Dickson

During their investigative interviews, both Perry and Tedrow indicated they were contacted by GOAA Board Member Hunt prior to the August 28, 2019 GOAA board meeting about the possibility of taking the position of interim general counsel GOAA General Counsel Marchena had previously announced that he would be resigning in December of 2019 Tedrow also thought that she was contacted by Dorworth about the same topic In addition, an in-person

meeting occurred on August 23, 2019 between Perry, Tedrow, Hunt, and Dorworth at Hunt's office. The meeting was in reference to the appointment process for the interim general counsel position. Neither Tedrow or Perry believed that Hunt was acting on the authority of GOAA in the meeting and also did not feel that the meeting had been discussed with other GOAA board members.

After the August 28, 2019 GOAA board meeting, Tedrow was contacted by Hunt multiple times about the possibility of Tedrow working with GOAA On September 10, 2019, Tedrow and members of her law firm met with GOAA CEO Brown at GOAA to discuss an engagement letter regarding the interim general counsel position and other issues regarding Tedrow's involvement with GOAA. There were not any GOAA board members present at the meeting in question Tedrow further met with GOAA Board Chairman Sanchez on September 12, 2019 to discuss the interim general counsel position. Additional phone calls took place between Tedrow and Hunt and Tedrow and Sanchez after the September 18, 2019 GOAA board meeting to discuss the possibilities of Tedrow's involvement with GOAA. Throughout all of the conversations and meetings referenced above, Tedrow did not have any reason to believe that Sunshine Law violations occurred. Investigative interviews conducted with GOAA board members also did not reveal any evidence to conclude that board members violated the Sunshine Law.

During his interview, GOAA Board Member Jason Pirozzolo stated that he was contacted by Shane Strum, Chief of Staff for the Executive Office of the Governor, about GOAA General Counsel Marchena Strum indicated to Pirozzolo that there were allegations of misappropriation of funds by the University of Central Florida where Marchena served as Chairman of the board of trustees Strum further told Pirozzolo to address the issue once he (Pirozzolo) was appointed to the GOAA board Pirozzolo brought up the topic at his first GOAA board meeting (approximately April or May of 2019) and recommended that an outside audit be conducted on GOAA however the other board members did not back the motion Pirozzolo also speculated that Dorworth likely wanted Tedrow appointed to the position of general counsel so he (Dorworth) would have a point of contact that he could approach about airport business

Other information obtained during the course of the investigation indicated that Dorworth stood a chance to benefit financially if Tedrow were appointed to the interim general counsel position Specifically, an allegation was made that Dorworth represented a vendor that conducted business at the Orlando airport. On November 19, 2020, Inspector Dickson and Chief Assistant Salmons conducted an interview with Dorworth.

Dorworth stated that he worked for the Ballard Partners Lobbying Firm in Tallahassee, Florida and that he was friends with several GOAA board members to include Pirozzolo, Carson Good, Hunt, and Sanchez Dorworth said there were concerns regarding GOAA finances and the reputation of GOAA General Counsel Marchena Florida Congressman Matt Gaetz wanted an audit to be conducted on GOAA and Dorworth believed that the concerns for an audit were discussed with some of the GOAA board members Pirozzolo made a motion during a board meeting to have an audit conducted but Dorworth said the motion was not well received which surprised him

Dorworth thought it was Hunt's idea to hire Perry and Tedrow as interim general counsel even though GOAA Board Chairman Sanchez actually made the motion. Dorworth stated that he discussed Perry and Tedrow with Hunt with the intention that they (Perry and Tedrow) would

assist in coordinating the audit on GOAA Dorworth did not have reason to believe that Sanchez and Hunt discussed the hiring of Perry and Tedrow outside of board meetings. Dorworth also stated that he was not used as a "conduit" between Hunt and Sanchez even though he did have independent conversations with them

Dorworth spoke with Board Members Good and Pirozzolo about the possibility of GOAA hiring Perry and Tedrow but did not have reason to believe that the topic was discussed with other board members. Dorworth did not represent any companies that did business with GOAA but stated it was possible that the Ballard Lobbying Firm did at some point in time. Dorworth stated that he would not have benefited in any way if Perry and Tedrow were named as interim general counsel. Dorworth also said that to his knowledge none of the GOAA board members would have benefited from Perry and Tedrow's appointment.

During the course of the investigation, no information was identified that indicated a violation of the Florida Sunshine Law occurred In addition, all information obtained during the investigation was reviewed by Chief Assistant Salmons who agreed with Inspector Dickson that each allegation was thoroughly investigated In December of 2020, after a full and complete investigation, the decision to close the investigation was made
