AND against the peace and dignity of the State of Florida.

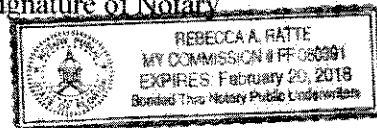

Larry Kerr was convicted of Possession of Child Pornography and his sentence was imposed on 10/25/1999 in the United States District Court Middle District of Florida, Orlando Division, case 98-145-CR-ORL-18C. His right to vote has not been restored in the State of Florida. On 09/20/08, Larry Kerr affirmed on a Florida Voter Registration Application that he was not a convicted felon. On 11/04/14, records reflect that he voted in the 2014 general election. In an interview Larry Kerr admitted that the signature on the voter registration application and the voting document appear to be his signature but he does not recall registering to vote or voting.
