On December 9, 2014, an investigation was initiated alleging Ricardo Pombo-Foster; w/m 04/27/1960, provided female children money and drugs to engage in sexual activity with him.

On December 30, 2014, an interview was conducted with a 16 year old female victim, who was 15 years old when the incidents occurred, who disclosed that sometime between July and August 2014, she engaged in sexual activity, to include; penile/vaginal intercourse, digital penetration, fellatio and cunnilingus, with Ricardo Pombo-Foster in exchange for money and prescription pills. The 16 year old female victim stated this incident occurred at Ricardo Pombo-Foster's residence, 2125 Seaport Cir. # 107, Winter Park, Seminole County.

On March 1, 2015, an interview was conducted with a 14 year old female victim, who disclosed that sometime between October 2014 and November 2014, she engaged in sexual activity, approximately 10 times, to include; penile/vaginal intercourse, with Ricardo Pombo-Foster in exchange for money and prescription pills. The 14 year old female victim disclosed that Ricardo Pombo-Foster took pictures and videos of her engaged in sexual activity with him on his cellular phone. The 14 year old female victim disclosed that Ricardo Pombo-Foster also took videos of him engaged in sexual activity with the 16 year old female victim as well. The 14 year old victim disclosed that

Ricardo Pombo-Foster had shown her the videos of the 16 year old female victim on his cellular phone.

Through the investigation Ricardo Pombo-Foster's account(s) associated with his cellular phone were identified and the content contained within was obtained. Upon review of the content there were 8 videos that depicted Ricardo Pombo-Foster engaged in sexual activity with the 16 year old female victim. The 8 videos were produced and recorded by Ricardo Pombo-Foster by use of his cellular phone. The 16 year old female victim was able to be identified in the videos, and the incidents occurred on the same day, which took place inside the residence of 2125 Seaport Cir. # 107, Winter Park, Seminole County.

There were 10 videos that depicted Ricardo Pombo-Foster engaged in sexual activity with the 14 year old female victim. The 10 videos were produced and recorded by Ricardo Pombo-Foster by use of his cellular phone. The 14 year old female victim was able to be identified in the videos. 7 of the 10 videos were recorded on 3 different days, between August 2014 and November 2014, which took place inside the residence of 2125 Seaport Cir. # 107, Winter Park, Seminole County. The other 3 videos took place at an unknown location.

On June 12, 2015, at approximately 0650 hours an interview was conducted with Ricardo Pombo-Foster at the Seminole County Sheriff's Office, 100 Bush Blvd., Sanford, Seminole County. During a post miranda interview Ricardo Pombo-Foster confirmed the account(s) associated with his cellular phone, but denied the allegations and requested a lawyer.

Due to the aforementioned information Ricardo Pombo-Foster was placed under arrest and transported to the John E. Polk Correctional Facility for the following violations:

- 15 counts - Florida Statute 827.071(3) Produce, direct, promote Sexual Performance by a Child under 18 years of age
- 18 counts - Florida Statute 827.071(5) Possession of Sexual Performance by a Child under 18 years of age
- 4 counts - Florida Statute 800.04(4)(a) Lewd or Lascivious Battery - victim 12 to 16 years of age
