IN THE NAME AND BY AUTHORITY OF THE STATE OF FLORIDA, PHIL ARCHER, STATE ATTORNEY, THROUGH THE UNDERSIGNED DESIGNATED ASSISTANT STATE ATTORNEY, CHARGES THAT:

COUNT 1: IN THE COUNTY OF SEMINOLE, STATE OF FLORIDA, on or about January 19, 2022, DA'RAVEIUS JANDAREUS JYRELL SMITH did attempt to commit a capital felony, to wit: FIRST DEGREE PREMEDITATED MURDER, to unlawfully kill a human being, said killing being perpetrated from a premeditated design to effect the death of and toward the commission of said offense, DA'RAVEIUS JANDAREUS JYRELL SMITH, did shoot with a firearm, and during the commission of said offense, DA'RAVEIUS JANDAREUS JYRELL SMITH actually possessed a firearm as that term is defined in Section 790.001, Florida Statutes, and further, during the commission of said offense, DA'RAVEIUS JANDAREUS JYRELL SMITH discharged said firearm, and as the result of said discharge, did inflict great bodily harm upon contrary to Sections 777.04(1), 777.04(4)(b), 782.04(1), 775.087, Florida Statutes,

COUNT 2: IN THE COUNTY OF SEMINOLE, STATE OF FLORIDA on or about January 19, 2022, DA'RAVEIUS JANDAREUS JYRELL SMITH did discharge any weapon or firearm while willfully and knowingly possessing a firearm, destructive device, or other weapon on the property of any school, contrary to Sections 790.115, Florida Statutes,

COUNT 3: IN THE COUNTY OF SEMINOLE, STATE OF FLORIDA on or about January 19, 2022, DA'RAVEIUS JANDAREUS JYRELL SMITH, did wantonly or maliciously, shoot at, within or into, a public or private building, contrary to Section 790.19, Florida Statutes,

AND against the peace and dignity of the State of Florida.
