The defendant got into an argument with his biological grandfather, William Womack Jr. (D.O.B. 6/22/1950), over him watching a television show. The defendant began throwing objects at William, to include a jar full of pennies, a glass bottle, motor oil bottles, and a bottle of detergent. William then tried to grab the defendant's wrists to prevent him from throwing more objects or from punching him. The defendant was able to pull away from William, and punched him twice in the side and top of the head. The defendant then took a wooden yard stick and struck William twice in the side of his torso. The defendant stated he struck the defendant hard enough to break William's ribs.

William then stepped out of the residence to get away from the defendant. The defendant retrieved a kitchen knife, which he described as a "butcher knife" with a serrated blade. The defendant then began to "slash" and "poke" William with the knife. The defendant struck William in the arm once and once in the head, causing superficial lacerations. William attempted to wrench the knife away from the defendant, but was unsuccessful. William then turned away from the defendant to walk away from him. The defendant then used both hands to push William, causing him to fall to the ground. The defendant stated he believed William was dead shortly after he hit the ground. The defendant then threw a hammer at the backside of William, approximately three times.

[REDACTED] At this time, William is unresponsive, and in the Intensive Care Unit (ICU) at Parrish Medical Center. The eleven counts of aggravated battery upon a person 65 years of age or older are summarized as follows:

- (1) Threw a detergent bottle, striking William.
- (2)(3) Punched William in the head with a closed fist.
- (4)(5) Struck William in his side with a wooden yard stick.
- (6)(7) Struck William in his arm and head with the serrated knife.
- (8) Pushed William to the ground.
- (9)(10)(11) Threw hammer(s) three times at the backside of William.
